Remember Joseph Schumpeter

In order to understand and give a useful explanation of actual social processes, and even more so, to look into the future of the rule of law and efficient economic dynamics, sound economic dogma does not give satisfactory reviews. From J. Schumpeter's point of view, the dynamic interpretation must be found and taken into account through the prism of the historicism of economic sociology and other sciences. The so-called, Open look into the future on the solid ground of a clear retrospective approach and available scientific and theoretical developments. In order to understand and give a useful explanation of actual social processes, and even more so, to look into the future of the rule of law and efficient economic dynamics, sound economic dogma does not give satisfactory reviews. Therefore, as an important synergistic component of this concept of economic efficiency, in our opinion, is the innovative development economics of Joseph Schumpeter, which received a scientometric justification in his Theory of Economic Development.

 It is he who owns the palm in introducing terminological clarity into the theory of understanding the difference between the well-known economic concepts of economic growth and development economics.

Economic dynamics (development)

- Economic dynamics (development) according to J.Schumpeter is associated with the phenomenon of something new, hitherto unseen by the individual. Prominent examples are the automobile and the train, the printing press and the steam engine. While economic growth is distinguished by him as a characteristic indicator of an increase in the production of certain goods and services over a certain period of time.
- At the same time, J. Schumpeter, developing Say's teachings, unequivocally emphasized the innovative power of an entrepreneur-innovator, projecting a powerful impulse to promote effective economic dynamics.
- When Joseph Schumpeter found the entrepreneur as an innovator, he
 postulated that a person is essentially an entrepreneur only when he
 promotes a new combination". This author presents this act as "creative
 destruction, since obsolete patterns are replaced in this place by the latest
 combinations"
- Efficient economic dynamics require the concentrated efforts of a whole mass of creative entrepreneurs who, in their activity, aim at the positive result of their dreams, experimenting with new combinations of factors of production. A bumpy road of trial and error, with a profit and loss system that creates fast feedback on the quality of these innovations, is the real potential for costeffectiveness on a digital platform, both today and in the future.

The Franco-Austrian-Norwegian (FAN) scientific tradition of innovation and entrepreneurship

- A significant contribution to the theory and modern conceptualization of the entrepreneur J. Schumpeter is made by the teachings of Professor Jan-Urban Sandal. Founded on Say, Schumpeter and Sandal, the Franco-Austrian-Norwegian (FAN) scientific tradition of innovation and entrepreneurship further develops the doctrine of innovation and entrepreneurship as a platform for economic dynamics.
- However, the positive result of the effectiveness of "creative destruction" of innovative entrepreneurship in the economic sphere, both in the present and in the future, is possible only if the economy is not static, structurally immobilized and not subject to corruption.

Democracy and Freedom

 One of the fairly understandable yet important principles of the rule of law orthodoxy is that there should be a clear separation between the private and the public in the economic sphere.

 Based on the past experience of the Tax Maidan, the Orange Revolution, the Revolution of Dignity and the current bloody struggle for independence, democracy and freedom have clearly crystallized in our national hierarchy of values.
