






- The values of international trade has increase tendency after DCFTA.


- The values of international trade has stable tendency after DCFTA.


These graphs show us about different tendency in development foreign trade in Republic of Moldova and Ukraine.

The analysis of the date can find general model for the investigation. It contents trend T and cyclic C components




## MODELS

- The trends have closed first point 38% for Moldova and 35% for Ukraine
- The curves of the trends is very different more then 11 times which indicates the impact of drastic components on the dynamics of cooperation with the EU. For the Moldovan economy, such dynamics are explained by the influence of the trend component, while the Ukrainian economy is subject to the influence of the cyclical component




These cyclical harmonics explain, respectively, 78% and 88% of the cyclical components of the development of trade with the EU

- The dynamics of the % of trade value have trend and cyclic components but the trend lines for each country are different
- general value of the % of trade with EU is around 35% that show structure of the trading for Moldova and Ukraine
- cyclic componentss are very strong for these series. and in the cyclic component
- In the cyclical component, long-term cycles with a period of 24 and 12 years have the greatest influence
